Dear Contest Mogul, LLC:

I wish to report a contest which I allege infringes the rights of a third party. I request that it be removed from the CreateMyTattoo.com website.

I state UNDER OATH and acknowledging that any false oath may be subject to PENALTY FOR PERJURY that:

1. I consent to Contest Mogul, LLC informing the alleged infringer of my claim and providing my email address by which the alleged individual can contact me;
2. The Intellectual Property Owner can provide proof that the IP Owner is the owner or licensee of the Intellectual Property Rights;
3. I am the owner, or an authorized agent of the Intellectual Property Owner, of certain Intellectual Property rights detailed below in Section A;
4. I have reasonable grounds to believe and in good faith allege that the Intellectual Property Rights have been infringed by the entry, contest or item(s) identified below in Section A and that the Intellectual Property Owner has not licensed or assigned Intellectual Property Rights to the alleged infringer or otherwise consented to or allowed authorization of the use of the Intellectual Property Rights;
5. The alleged infringement of the Intellectual Property Rights is causing the Intellectual Property Owner to suffer loss or damage or to devalue the Intellectual Property Rights;
6. Unless the Infringing Item is removed from the CreateMyTattoo website, the Intellectual Property Owner will continue to suffer loss or damage or devaluation of the Intellectual Property Rights;
7. The information provided in this Notice is true, accurate and correct in every particular.
